Father Jay led Evening Prayer.

Motion: Ellen Gregan, seconded by Chris Ellis to accept the January 2021 minutes. Motion passed unanimously.

Motion: C. Ellis, seconded by Chuch Messley, to accept the January 2021 financial report, as amended. Motion passed unanimously.

Sunday attendance averaged 28.6 in January in the Zoom worship services.
